Please note:

1. Each Rider MUST nominate 1 cross country judges before entries will be accepted.
2. The committee of Penola Pony Club Inc reserves the right to accept or reject any entry without entering into any correspondence.
3. The committee reserves the right to classify all competitors, divide sections, to restrict entries or cancel a section if necessary.
4. Safety Helmets complying with AS/NZS 3838, EN1384 or ASTM 1163 standards and riding boots must be worn at all times whilst mounted. This applies to Adult riders as well as Pony Club riders.
5. All riders must have a gear and safety check before every phase of the competition.
6. No refunds will be given after the closing date.
7. Cards and Helmets to be presented to event secretary's office before collecting body numbers. Riders must supply their own body number holders.
8. Medical Armbands must be worn for the cross country phase.
9. At the discretion of the committee, elimination in one phase will not stop you from competing in other phases.
10. This event is to be run under PCASA rules. The PCASA rules and by-laws will apply for all sections.
11. A second qualified Horse may be entered. Competitors may ride a maximum of 2 horses in each grade. Refer to Rule 1.7 PCASA. No phase will be held for a competitor unless a member of the committee is notified.
12. Camping and yards are available. See fees below.
13. Protests are to be in writing no later than 30 minutes after results have been posted in early phases or 10 minutes after final results. Protests are to be accompanied with a \$50 fee. Refer to PCASA rule 5.4.
14. Full Pony Club Uniform must be worn at the un-mounted presentation. Refer to PCASA Rule 5.8.
15. The draw will be emailed to all club secretary's and Adult Riders on 28<sup>th</sup> April.

**Entries:**

Pony Club entries are to be made on the Pony Club Entry Form, Signed by Club secretary and accompanied by entry fees. Club secretaries are responsible for ensuring that competitor's cards are correctly graded and combinations are qualified. Dates of qualifications are to be also written on the entry forms. You must have 4 qualifications per rider as per PCASA rules within the previous 12 months. If Combinations have not obtained 4 qualifications the combination will be able to compete H/C provided a card is produced. Adult competitors are to enter on an adult Entry form and be accompanied by entry fees. Adult riders competing must be current financial members of an affiliated Pony Club or riders who are not members of a Pony Club must have paid the annual affiliation fee to the state office and produce their card as proof.

Late Entries will not be accepted.

**Fees:**

Yards	\$10 per yard

**Course Closure:**

Schooling of horses is prohibited before, during and after this event. The course will be closed at 6pm on the 2<sup>th</sup> April.
